Purchaser Agrees That It Will: Provide Artist with complimentary water and soft drinks as available. In addition, two tables will be provided for band personnel as well as a band changing area.
- 11) **Artist Agrees That It Will:** Provide Purchaser with a minimum of five posters for event and actively promote event via online outlets. Artist will not perform another public show within two weeks within a 25-minute drive of venue, unless approved by Purchaser and/or Agent.
- 12) **Artist will leave stage, green room, and any areas given to the Artist in the condition as it was when they arrive at venue.**
- 13) **Force Majeure:** The present contract will be invalid if an act of God occurs. In no event shall either party be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation to, strikes, work stoppages, epidemics, accidents, pandemics, acts of war or terrorism, civil or military disturbances, nuclear or natural catastrophes or acts of God. In such cases, each party will assume their respective expenses.
- 14) **Payment by Purchaser** after completion of the services shall be deemed acknowledgement between both parties that the quality of the services is satisfactory to Purchaser and shall release Artist from any and all liability and claims to Purchaser regarding such services.
- 15) **If Artist is unable to perform** after signature of this contract, Agent reserves the right To replace Artist with comparable act for comparable wages, with Purchaser approval.
- 16) **If Purchaser fails to comply** with any of its responsibilities hereunder, Artist may terminate and retain any amounts paid by Purchaser prior to termination.
- 17) **This Agreement may not be altered** by either party unless done so via written Instrument by both parties. This agreement may not be transferred and/or assigned to a third party by either the Artist(s) or the Purchaser.
- 18) **This constitutes the entire Agreement between Purchaser and Artist**, and may not be modified, changed or terminated in any way except in writing signed by both parties. This agreement shall be governed by and construed in accordance with the laws of Illinois. Any legal actions, claims or demands shall be handled in a court within

the county.
